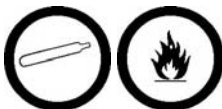

Eliminate ignition sources

Stop leak - ONLY if possible to do so without risk.

- **Measures for environmental protection:** Prevent seepage into sewage system, workpits and/or cellars.
