In case of irregular breathing or respiratory arrest provide artificial respiration.

cylinders should be segregated. Use a "first in-first out" inventory system to prevent full cylinders being stored for excessive periods of time.

· **Information about storage in one common storage facility:**

Store away from oxidizing agents.

Store separately from cylinders containing oxygen or oxidants by a minimum distance of 20' or by a barrier of non-combustible material at least 5' high having a fire resistant rating of at least 30minutes.

Sources of ignition should be removed from storage area.

· **Further information about storage conditions:**

Keep cylinder valve tightly closed.

Store in cool, dry conditions in well sealed receptacles.

Protect from heat and direct sunlight.
